1. Charges applicable from 15 December 2025 and are subject to change without notice.
2. All prices exclude G.S.T.
3. All prices include the Section 99 Government Waste Levy.
4. All vehicles are weighed in and out on our fully certified weighbridges to calculate the net weight disposed.
5. Prices are based on the waste type.
6. All waste will be inspected at each site by a Waste Inspector both before and during unloading.
7. Non-account customers paying by cash, credit card or EFTPOS will be required to leave suitable identification at the weighbridge before tipping.
8. All goods invoiced as per signed weighbridge docket. No classification disputes will be accepted.
9. Our current "Conditions of Sale" and credit terms apply.
10. Benedict Recycling Newcastle Pty Ltd does not accept any non-conforming or hazardous materials that do not appear on our EPA licence, including but not limited to: liquid waste, asbestos or putrescible waste.
11. Minimum transaction fee applies for all waste streams, please refer to our Gate Rates located at www.benedict.com.au for rates associated with each recycling facility.
12. NRECW will be charged at net weight x your light demolition rate.

Please note: We also offer a free drop-off service for all scrap metals from any residential clean ups.
