- Prices are based on the waste type.
- All waste will be inspected at each site by a Waste Inspector both before and during unloading.
- Non-account customers paying by cash, credit card or EFTPOS will be required to leave suitable identification at the weighbridge before tipping.
- All goods invoiced as per signed weighbridge docket. No classification disputes will be accepted.
- Our current "Conditions of Sale" and credit terms apply.
- Benedict Recycling does not accept any non-conforming or hazardous materials that do not appear on our EPA licence, including but not limited to: liquid waste, asbestos or putrescible waste.
- Minimum transaction fee applies for all waste streams, please refer to our Gate Rates located at www.benedictrecycling.com.au for rates associated with each recycling facility.
- NRECW will be charged at net weight x your light demolition rate.
